TO RHODE ISLAND STATE SOCIAL SECURITY AGREEMENT

The Secretary of Health, Education and Welfare and the State of Rhode Island acting through its representative designated to administer its responsibilities under the Agreement of December 20, 1951, hereby accept as additional coverage groups (as defined in Section 218 (b)(5) of the Act) under said agreement and acknowledge full applicability of the original Agreement to the following:

STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS

"Services performed by employees including services performed by employees in positions covered by the Employees' Retirement System of the State of Rhode Island but who are ineligible to be members of such system."

"It is further agreed that the services of any employee referred to in this Modification shall continue to be covered by the said agreement if, after the effective date specified herein, he becomes eligible to be a member of a retirement system."

The effective date for coverage of this group shall be ~~October 1, 1955~~ *January 1, 1956*.

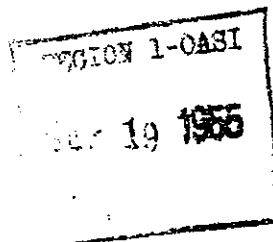
