To the State of Rhode Island
STATE SOCIAL SECURITY AGREEMENT

Whereas, the Secretary of Health and Human Services and the State of Rhode Island, acting through its representative designated to administer its responsibilities entered into an agreement on December 20, 1951 for the purpose of extending coverage under the provisions of the Social Security Act, as amended, to the employees of the State and the political subdivisions of the State; and


Whereas, the State of Rhode Island had extended coverage effective January 1, 1951, under Section 213 to the services of the employees of the Town of East Greenwich 69-0150007 in all coverage groups (as defined in Section 213 (b) (5) of the Act) by means of Original Agreement.

Whereas, the Town of East Greenwich filed wage reports and made payments of contributions for the employees of the East Greenwich Housing Authority a separate political subdivision, under the name and identification number of the Town of East Greenwich for periods after January 1, 1977, in the belief that such action would result in coverage for the employees of the East Greenwich Housing Authority under the provisions of the Social Security Act, as amended; and

Whereas, the filing of such wage reports and contribution returns was erroneous;

Now, Therefore, the Secretary of Health and Human Services and the State of Rhode Island acting through its representative designated to administer its responsibilities under the above agreement, hereby agree to and by this modification do correct the error to which reference is made above by extending coverage under Section 213 to the services of the East Greenwich Housing Authority, a political subdivision of the State of Rhode Island, in all coverage groups (as defined in Section 213 (b) (5) of the Act) with coverage effective as of January 1, 1977, the beginning of the period for which wage reports were first erroneously filed
