### MODIFICATION NO. 35

#### TO RHODE ISLAND STATE SOCIAL SECURITY AGREEMENT

The Secretary of Health, Education, and Welfare and the State of Rhode Island, acting through its representative designated to administer its responsibilities under the agreement of December 20, 1951, hereby accept the following amendment to said agreement:

Subdivision (b) of said agreement (Services Covered), as previously amended, is further amended so that the subparagraph thereof numbered (ii) shall read:

"(ii) Any service other than services described in section 218 (d)(8) of the Federal Social Security Act performed by an employee in a position which is not a policeman's or fireman's position and which, on September 1, 1954, or on the date this agreement is made applicable to such coverage group (as defined in section 218 (b)(5) of the Federal Social Security Act), is covered by a retirement system other than--"
