**PORTFOLIO PERFORMANCE**

**December**

The ERSRI portfolio posted a gain of 0.77% for the month of December, against the policy index of 1.27%. Domestic equities gained 1.13%, international equities gained 3.20%, and the fixed income asset class returned -0.71%. Additionally, the retirement fund earned \$219,575 from the securities lending program during this month.

**Calendar Year to Date**

For the twelve months ended December 31, 2006, the portfolio is up 14.89% against the policy index of 15.50%. Domestic equities were up 15.55%, international equities were up 26.94%, while fixed income generated a return of 4.28%.

**Fiscal Year to Date**

For the Fiscal Year ended June 30, 2007, the fund has gained 9.27%, against the policy index of 10.90%.

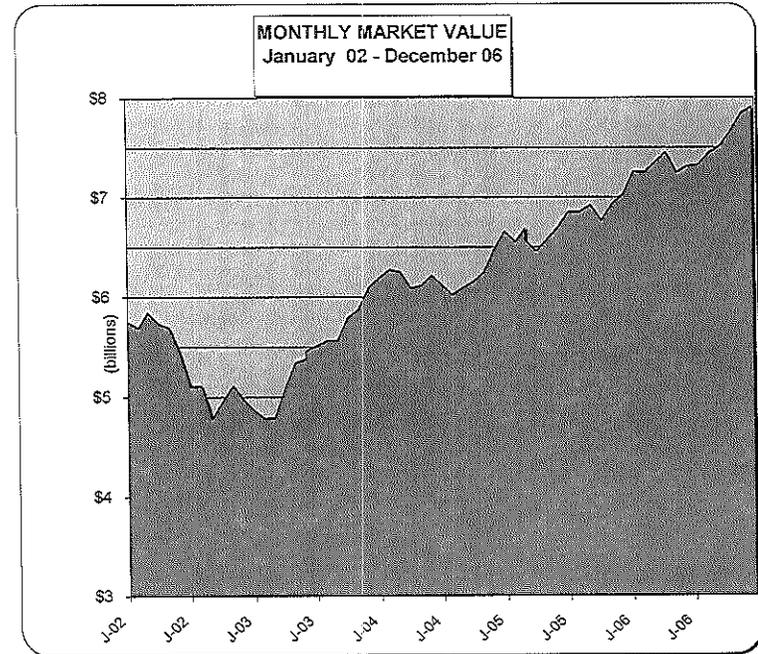

Market Valuation Report  
December, 2006

Market Values

The total portfolio value increased in December by \$59.6 million to \$7.90 billion. This compares with an increase in value of \$86.3 million for the same period in 2005. The domestic equity market values increased by \$29.4 million, including a transfer out of \$8 million; fixed income decreased by \$13.1 million; while international values increased by \$51.0 million, including an \$8.0 million transfer out. The cash accounts increased by \$17.0 million including transfers in of \$14.1 million, and alternative investments decreased by \$24.7 million including transfers out netting \$11.7 million.



### Cash Flow

December's pension payroll of \$54.9 million was more than the \$ 47.8 million in contributions and wire transfers received by \$7.1 million.

To meet pension and other obligations, \$12.0 million was transferred from long-term investments.

### Alternative Investments

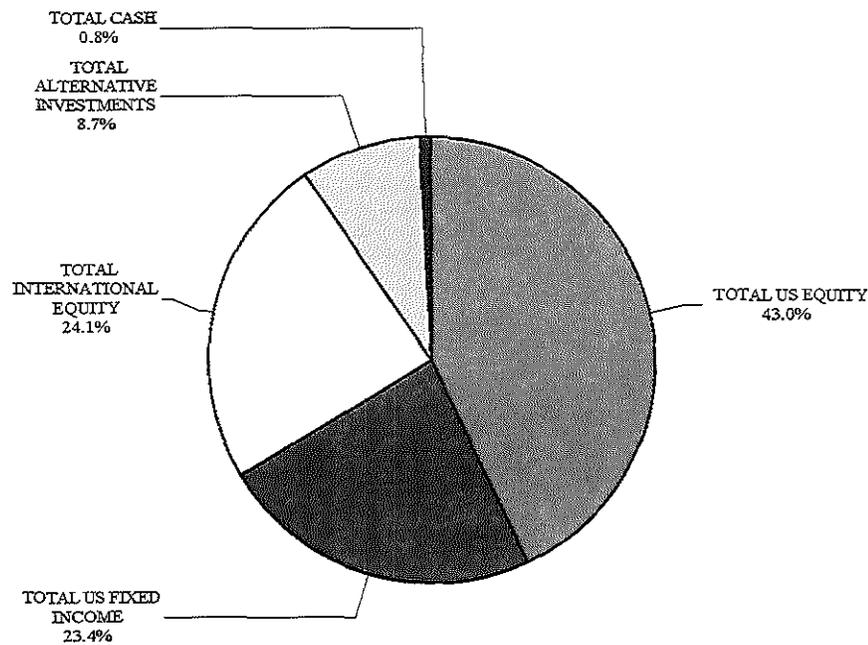
At this time the alternative investment asset class has unfunded commitments of approximately \$406 million on commitments of \$863 million.

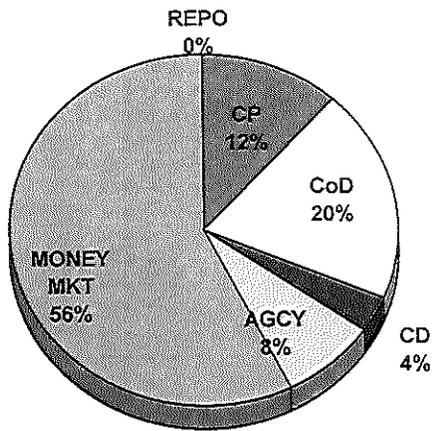
CURRENT ASSET CLASS ALLOCATION (IN MILLIONS)



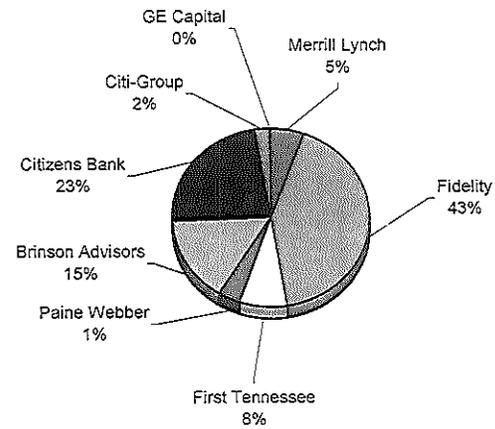

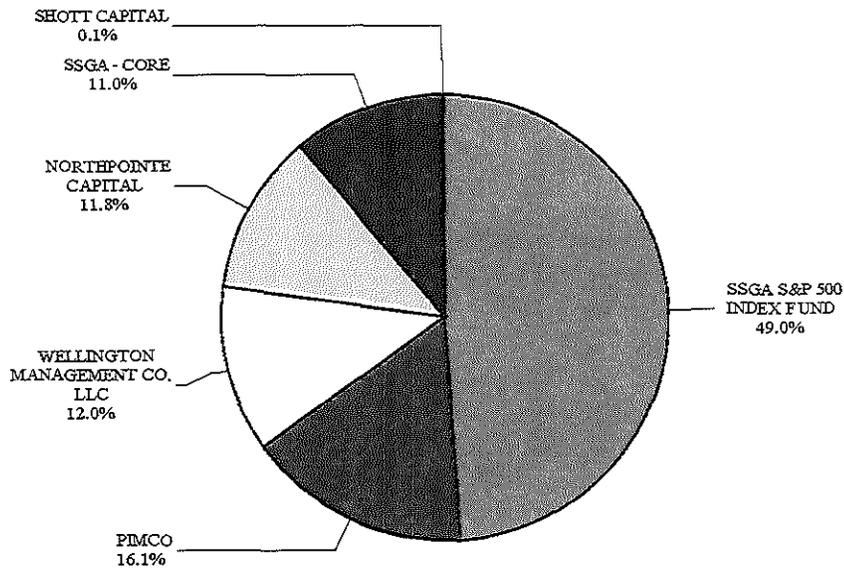

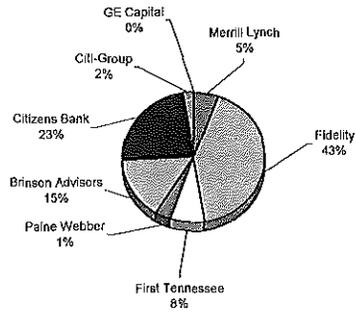
