I request all death benefit information and changes for the last 2 years from July 31, 2012 to July 31, 2014 to include beneficiary nomination for primary and contingent beneficiaries, any refund of contributions, and death benefit payouts.

I thank you for the quick response in February. In review, this is not all the information I expected and perhaps I was not clear nor stated correctly as the estate administrator. Documentation and information held by the State of Rhode Island is required to validate issues and claims within the Estate of John T. Sharkey.

- 1. I expected and still request the file copy of the ERSRI Beneficiary Nomination Form that would list all beneficiaries (if any), "Beneficiary Type, OAP Election, and Benefit Type" or during circa 2006 a form called "Option Selection Form (Employees Retirement System for SRA, Option 1 Joint and Survivor 100%, Option 2 Joint & Survivor 50%, or SRA Plus Social Security Option)". And when was the official filing last updated? In review, there was no copy of the official filing provided and perhaps the date scope was incorrect.
- 2. It is known that John Sharkey is divorced to Karen I. Anjoorian. I was seeking information if a qualified domestic relations order is in place and is exercised.
- 3. Provided is the estate's copy of the ESRI purchase and 30-Day retirement letter. I was seeking the State of Rhode Island copy to validate the Estate copy for the determination of John's retirement payment.

I believe my request is valid and is within the original scope of the initial request filed on 2/1/2015 to document for the court beneficiary status that John Sharkey filed or perhaps did not exercise, and did not file with the State of Rhode Island. The contents of this email constituted the FOIA request.
