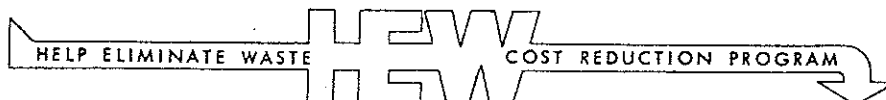
These Modifications have been reviewed by this office and cleared for approval by the Regional Attorney.
