SUBJECT: Approval of Modification No. 1 of the Coverage Agreement with the
State of Rhode Island

Enclosed is Modification No. 1, in duplicate, of the coverage agreement with the State of Rhode Island which extends coverage to four additional political subdivisions of the State. The modification was signed by the appropriate State official, Raymond H. Hawksley, General Treasurer, on behalf of the State of Rhode Island. Execution of the original agreement with the State of Rhode Island was completed in the State on December 20, 1951.

Modification No. 1 extends coverage effective January 1, 1952, to the employees of 3 towns and 1 city. As originally prepared the signature line for the Federal official reads "approved for the Federal Security Administrator this twentieth day of March 1952." We have changed this so that the current date of signing by the Director will be indicated.

It is recommended that the Director approve, date and sign the enclosed Modification No. 1, in duplicate, pursuant to the authority delegated by the Administrator and that the enclosed letter to the State official be released. This submittal and the enclosed Modification No. 1 have been cleared with the Office of the General Counsel.
