(a) A vote by written ballot was held on June 26, 1972 on the question of whether services of employees of the Exeter-West Greenwich Regional School District in positions covered by Employees Retirement System of the State of Rhode Island should be included under the agreement entered into on December 20, 1951 by the State of Rhode Island and the Secretary of Health, Education, and Welfare pursuant to Section 218 of the Social Security Act;

(b) An opportunity to vote was given to all individuals who were members of the Employees Retirement System of the State of Rhode Island at the time the vote was held;


(c) Not less than ninety days notice of such vote was given to all individuals who were members of such system on the date the notice was issued;

(e) The Employees Retirement System of the State of Rhode Island was divided into two parts or divisions in accordance with the desires of the membership of the system.

With respect to Modification No. 83, we note that section 45-31-9 of the General Laws of Rhode Island provides for the creation of a redevelopment agency in each community. Section 45-31-16 further states that any redevelopment agency created under prior law shall constitute such an agency for purposes of section 45-31-9 and shall have all the rights, powers, duties, and exemptions granted to agencies established under the latter section. Section 45-32-5 in turn constitutes each redevelopment agency " *** a public body, corporate and politic, exercising public and essential governmental functions *** including the powers *** to sue and be sued; borrow money; to compromise and settle claims; to have a seal; to make and execute contracts and other instruments *** to make *** and repeal by-laws ***." It is apparent, therefore, that such agencies constitute separate "political subdivisions" for section 218 purposes.
