We looked into this and it appears that both individuals received a retroactive payment.

- Mark Doyle received a payment in June 2014 retroactive to June 2, 2013 (date of termination) – hence why his gross was high, but base is accurate.
- Antonio Leite received a payment in June 2014 retroactive to March 22, 2014 (date of retirement) – again base amount is accurate.

Also, they were located on the MERS Disability Pension attachment not ERSRI state employees.
